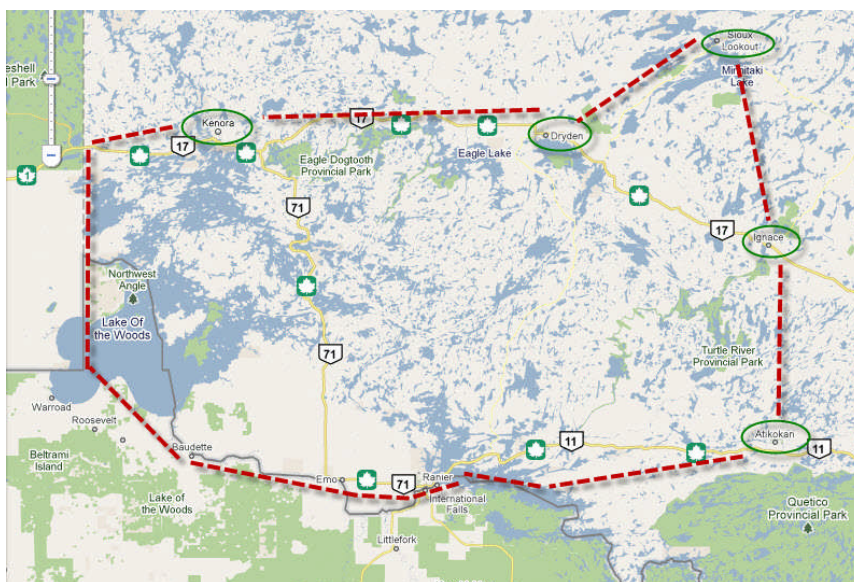


**Agreement between:

The Ontario Physique Association (OPA)**

Re: Ontario Athletes Competing within the MABBA

The following points are understood and agreed upon:

1. Ontario Athletes wishing to compete within MABBA *must* reside within the following easterly most boundaries: Sioux Lookout on Highway 72, Ignace on Highway 17, and Atikokan on Highway 11. Any athlete residing east of this boundary must compete within the OPA.



2. Ontario Athletes residing within this boundary and wishing to compete within the MABBA must adhere to the following rules:

- a) Purchase a membership from MABBA and follow all By Laws, Rules and Regulations and any other and all policies as laid down by MABBA
- b) The OPA, must be informed by MABBA that a resident of Ontario within the agreed region has purchased a membership from MABBA
- c) Ontario athletes competing within MABBA will follow the Tier System of MABBA and will not be allowed to use any placements obtained with MABBA for competitive purposes within the OPA.
- d) If at any time, an Ontario athlete, who continues to reside within the designated boundary and withdraws his or her membership from MABBA, will no longer be allowed to be a member of MABBA. If any such athlete then desires to compete within the OPA, that member must purchase the OPA regular membership, and commence competition at the lowest Regional Level.
- e) It is recognized that athletes who reside within the designated boundary, are not compelled to join or compete within MABBA.
